



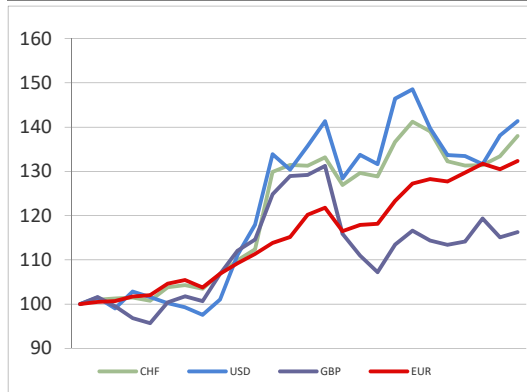
**Investment Objective**

It is the aim of the fund to develop a new class of investments for investors with the purchase, rental and trade of classic cars. The fund offers a platform for investors who want to diversify their portfolio. The purchase of sports and luxury models is intended to achieve above-average returns. In order to reach this goal, the fund manager will enrich the portfolio with vehicles from the history of racing. These vehicles are especially valuable if they won races.

**Investment Strategy**

In addition to this the fund can participate in companies and suppliers of the automotive industry and in the area of non-renewable energies by purchasing value rights; the fund can also invest in precious metals. All vehicles are safely stored and insured. This is to say that all fund investors can view the vehicles. At least once a year every vehicle is presented to the investor. In addition to this these vehicles are shown at classic car exhibitions or rented to museums and the film industry in order to increase their reputation.

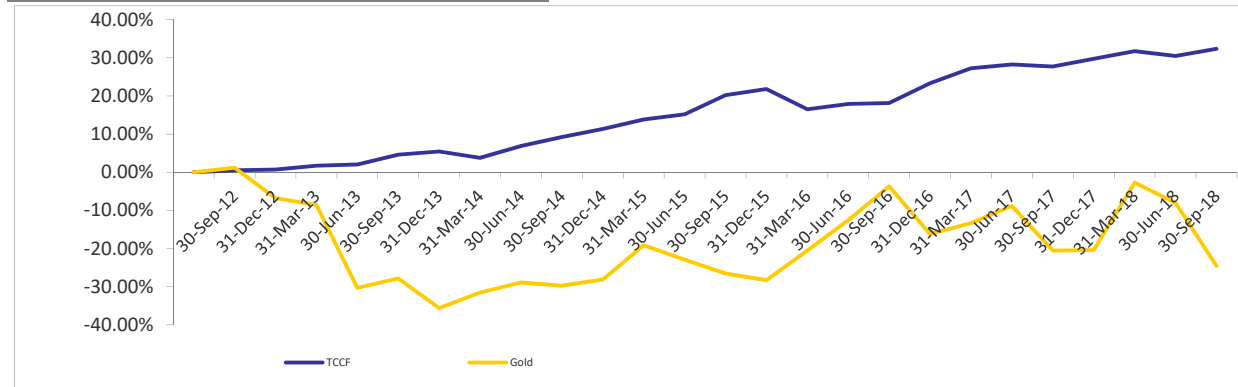

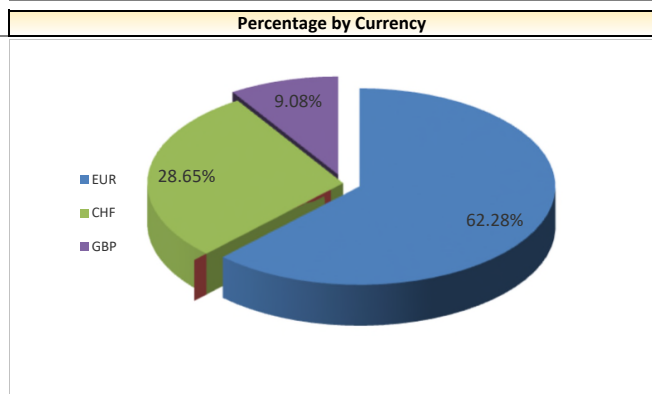
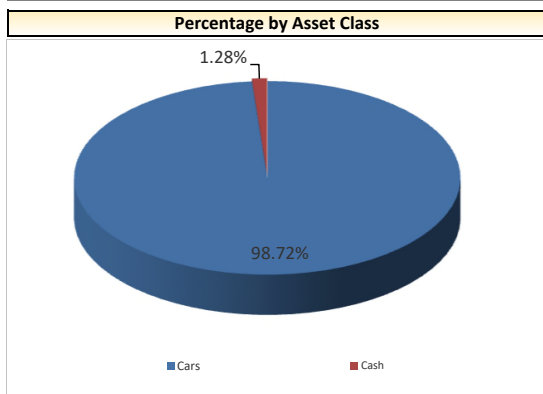
